QUARTERLY REPORTS

President Chavers stated we would forego the quarterly reports as they were presented at the Subcommittees.

BIA-MN AGENCY: James 'Chris' Redman, Acting Superintendent Bob Lintelmen, BIA Forester

Acting Superintendent Redman gave a brief introduction of himself, along with contact information.

Forester Lintelman presented the BIA report. He informed the Committee that the MN Agency has been fully staffed since July 11, 2022.

He discussed the Partners in Action 2022, Together Towards Tomorrow, July 18^{th} - 29^{th} and August 8^{th} – 19^{th} . This would be the 12 Annual conference with 75 available sessions. This conference will be held virtually again, session delivered primarily via Microsoft Teams platform.

He also informed the Committee of the current vacancies within the MN agency along with the Fire activity. Fee-to-Trust has only one person, Secretary-Treasurer McCormick asked expressly of Acting Superintendent Redman that the Region fast track all fee-to-trust applications and assign someone to help Annabell Kingbird. We need Fee-to-Trust to be a priority after years of waiting for the BIA regarding the Solicitor's UFJ opinion. Acting Superintendent Redman responded that Superintendent Fogerty wanted to do more but there were limited resources available.

REFERENDUM BALLOT UPDATE

Executive Director, Gary Frazer presented the statistics involved in the response rate for the referendum, described challenges with outdated address lists and how MCT handled it. On July 20, MCT staff will be counting the responses and invited tribal leaders to send over individuals to help. Committee members discussed the results and determined to have a review of successes and gaps of the referendum process in order to improve voter participation and improve voter education.

LEGAL: BRODEEN & PAULSON

We have a very active Supreme Court – Castro Huerta v. Oklahoma decision regarding state jurisdiction, recommend your legal to evaluate its implications. Legislation coming before the Supreme Court is the Brackeen Case, Native American Rights Fund is preparing an amicus brief and requesting tribes to sign on as amicus curiae for the Fifth Circuit Court.

NEW BUSINESS

Sandy Lake Boundary Resolution presented by Jean Skinaway. Tribal Executive Committee discussed at length, including language changes: eliminating 'trust' from 'trust lands' and updating the language 'special' to 'regular' in regards to the certification of meeting. Two points were made whether or not this resolution has made its way through legal review and that land in question's title is held with the BIA records, which was not part of the commentary today. Phil Brodeen has reviewed it. President Chavers asked Chief Executive Benjamin if she would like the language to be reviewed by a Mille Lacs Attorney. Chief Executive Benjamin, if you want my recommendation, call for a vote. President Chavers calls for a vote on the Resolution:

Motion by Chairman Dupuis to approve the Sandy Lake Resolution with changes. Seconded by Chairman Deschampe. 9 For, 0 Against, 2 Silent (Chief Executive Benjamin, Secretary-Treasurer Boyd). Carried.

Chief Executive Benjamin offered comments regarding Mille Lacs Band of Ojibwe's position to vote silent, reiterating past statements to the Tribal Executive Committee to recognize that the Band is in a legal fight with the counties. The boundaries are part of the legal documentation and legal arguments which are ongoing, and we are not able to bring anything up or be part of the discussion on this topic, the discussion is one-sided.

Topic raised for discussion by Dawn Goodwin: MCT Land Transfer Bill Resolution passed by the TEC 2019.

President Chavers described the land title issue of Minnesota Chippewa Tribe Trust Land which is managed by each of the Bands, and described concerns about federal formulas using land bases as part of the determination on funding for tribes. Discussion centered around the history of the land from the treaty era to present title of trust land by BIA. Chairman Jackson remarked on tribal sovereignty and the benefits for home leases approved under the HEARTH Act by the bands. Secretary-Treasurer McCormick offered an opportunity to host an informational session with tribal leaders and members regarding the title of land and the six band's land use and realty managers efforts to restore reservation lands reserved by treaties.

President Chavers called for a motion to adjourn:
