President Johnson offered – as part of PIIC culture – presenting a gift to MCT on behalf of the Lakota/Dakota community. A beautiful wool blanket presented to President Cathy Chavers.

President Chavers thanked the PHC tribal council for their very powerful presentation. Chief Executive Benjamin said Miigwetch to the PHC representatives for their excellent presentation on how they would like to move forward and protect their membership.

NEW BUSINESS

President Chavers presented the Committee with a letter from the Northeastern Minnesota Synod of the Evangelical Lutheran Church in America (ELCA) recognizing the history of injustice and atrocities, acknowledging treaties and land cessation, their belief in the Creator's call to do justice, and referring to the sale of property and benefit of the sale and assets they have been given over generations. The Synod Council has pledged to gift a reparation to the Minnesota Chippewa Tribe underscoring their understanding of the significance of the treaties of 1854, 1855, and 1866 and as a beginning point to repairing the breach that has historically occurred between us and among us.
